

# Terms and Conditions

1. This Promotion is open to existing JP Corry Trade Account, Cash Sale Discount Card Holders and non-account customers.

Participants must be aged 18 or over and cannot be employees of JP Corry (The 'Promoter'), an Employee's immediate family, their agents or anyone else professionally connected with this promotion.

Any Account holders who are public sector organisations or housing associations may not participate within this Promotion and will not be included within the definition of Participants. If there is any uncertainty as to who may be a Participant, please contact the JP Corry Marketing Department on 0280902403661 whose decision shall be final and binding.

2. The Promoter reserves the right in its sole discretion to ask for evidence to verify the age, identity and/or eligibility of a Participant at any time, and to use any channels and methods available to carry out checks of any details provided, especially at the point that the Award (as defined below) is provided. The Promoter may withhold an Award until it has received such evidence and failure to provide such evidence in a timely manner may result in forfeiture of an Award.

3. This Promotion will run from when a JP Corry branch Opens on 1st May 2018 (the "Start Date") until a Branch closes on 31st May 2018 (the "Closing Date") (the "Promotion Period"). 4. Subject to clause 16, if a Participant spends as follows on collect orders (each an "Order") through an Account during the Promotion Period (the "Qualifying Spend"), and registers online at [www.jpccorry.com/worldcuppromo](http://www.jpccorry.com/worldcuppromo) they will qualify for an award:

a. At least two hundred and fifty pounds (£250.00) (excluding VAT) on one or more orders, one pre-paid card with the value of (£5.00) (including VAT) (a "pre-paid card"/the "Award").

b. At least five hundred pounds (£500.00) (excluding VAT) on one or more orders, one pre-paid card with the value of ten pounds (£10.00) (including VAT) (a "pre-paid card"/the "Award").

c. At least one thousand pounds (£1,000.00) (excluding VAT) on one or more orders, one pre-paid card with the value of twenty pounds (£20.00) (including VAT) (a "pre-paid card"/the "Award").

d. Non account customers are eligible however the spend must occur in a single transaction.

Any Qualifying Spend by a Participant over and above one thousand pounds (£1,000.00) during the Promotion Period will not carry over to a further Award. A maximum of one pre-paid card may be awarded to a Participant (no matter how many Accounts they have or how many Orders they make or how much they spend) during the Promotion Period. The highest value Award as outlined above that has been qualified for will be awarded. Customers who achieve an Award between the Start Date and the Closing Date will be contacted after the Promotion Period by email to advise they have qualified for the award. The award will be posted to the address highlighted on account.

7. Each pre-paid card will be loaded with the Award value to be used at any Venue/merchant that accepts MasterCard's.

a. Nothing in these terms and conditions shall exclude or limit the Promoter's or its third party supplier's liability for death or personal injury caused by their staff or supplier's negligence or for fraud.

b. Subject to 10a, the Promoter does not accept responsibility for any fault, malfunction, damage, loss or disappointment suffered by a Participant howsoever arising from accepting any Award whether due to any error, omission or other cause by the Promoter or its employees, agents or others.

c. Subject to 10a, the Promoter is not responsible for any damage or loss caused to a Participant (i) which is not reasonably foreseeable to the Participant and to the Promoter when the Participant agrees to these terms and conditions (which occurs automatically when the Participant participates in this Promotion) or (ii) is reasonably foreseeable to the Participant and to the Promoter when the Participant agrees to these terms and conditions but is only indirectly related to the Participant participating in this Promotion.

d. Subject to 10a, the Promoter reserves the right to amend any element of this Promotion, or foreclose this Promotion and cannot be held responsible for failure to deliver for reasons beyond its reasonable control, including but not limited to strike, lock-out, labour dispute, illness, act of God, natural disaster, adverse weather conditions, war, riot, civil commotion, accident, epidemic or pandemic, malicious damage, fire, flood and/or storm, compliance with law or governmental order, rule, regulation or direction, breakdown of plant, machinery or transportation. The Promoter is not responsible for any loss or damage caused to the Participant as a result of any of these occurrences.
