



# KAMADO JOE BBQ COMPETITION

**\*\*Terms and Conditions: JP Corry Kamado Joe BBQ Competition\*\***

## 1. **\*\*Eligibility:\*\***

- The Kamado Joe BBQ Competition (hereinafter referred to as "the Competition") is open to legal residents of Northern Ireland, aged 18 years or older at the time of entry.
- Employees of Kamado Joe and JP Corry and its affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members are not eligible to participate in the Competition.

## 2. **\*\*Entry:\*\***
