Application Methods

Brush Ronseal Sprayer

May require an additional coat(s) if applying to very weathered wood or over a very contrasting colour. Maintenance Gives colour protection for up to five years. Inspect annually, and re-coat if areas of failure observed.

Clean up any drips onto plants, paving, etc with water straight away.
